Towards family support: key legislation (1)

Children Act 1948

- Creation of local authority Children's Departments
- Support for 'boarding-out' as an alternative to residential care
- Registration and inspection of voluntary agencies
- Restoration of children with families

Children and Young Person's Act 1963

- Response to the problem of 'juvenile delinquency'
- "Gives the go-ahead for LA children's departments to actively 'promote the welfare' of children through practical assistance families become the client group (Hendrick, 2003)

Towards family support: key legislation (2)

"We recommend a new local authority department, providing a community based and family oriented service, which will be available to all. This new department will, we believe, reach far beyond the discovery and rescue of social casualties; it will enable the greatest possible number of individuals to act reciprocally, giving and receiving service for the well-being of the whole community." (Seebohm Committee 1968: paragraph 2).

Local Authority Social Services Act 1970

- Creates new unified Social Services departments (incorporating Children's Departments)
- Conservative minister Keith Joseph tells the new departments plan for annual budget increases of 10 per cent (Jones, 2020: 125)

The development of 'child protection'

Failing to intervene to protect children from parents

- The discovery of 'battered babies' in the United States
- The Maria Colwell Inquiry (1974)
- More inquires through the 1980s e.g. Beckford, Carlile, Henry

Social workers with too much power?

• Cleveland Inquiry

Children Act 1989

- Section 47: legal framework for child protection
- Section 17: family support for 'children in need' has it ever been implemented?

Fiscal crisis, the New Right and Conservative Governments (1979-1997)

- Unemployment
- Means testing e.g. school meals
- Regressive taxation
- New Public Management
- Child poverty rises from 1 in 10 to about a third strong link to health inequalities
