# RULES FOR READERS

## Access and use

1. An external reader will be required to supply two forms of identification, one of which must be photographic, such as a passport or driving licence. Members of King's College London are required to show their College identification card. The College also reserves the right to require letters of introduction for researchers wishing to access confidential or closed records.
2. Appointments to consult all archive material should be arranged in advance. Use of resources held in the Reading Room does not require an appointment.
3. All applications to have access to the holdings of the Centre must be made on the forms provided and be signed by the applicant.
4. Readers are responsible for all items issued to them. Papers and other materials must be handled with the utmost care as described in the document handling guidelines displayed in the Reading Room. Papers must be kept in their correct order and must not be removed from their folders.
5. Readers may take notes using pencils, lap top computers or mobile devices. Dictation devices may also be used, provided their use does not disturb others. The use of any kind of ink pen is forbidden.
6. On completion of work for the day readers may be required to make their working notes available for a brief security check.
7. Readers may not eat, drink or smoke in the Reading Room.
8. Mobile phones must be silent or switched off in the Reading Room.
9. Copies of papers and digitised images may be provided for registered readers, and digital photography allowed, at the discretion of Archives Services staff on completion of a copyright declaration form. Papers will be stamped on every page "Supplied for research only. No documents or images may be reproduced or published without prior permission".

## Publication

1. Readers wishing to publish an image or a manuscript deriving or quoting from any material held in this archive must seek either the permission of King's College London, or the Trustees of the Liddell Hart Centre for Military Archives, as appropriate, prior to publication.
2. For a small number of brief quotations, a request submitted in writing to Archives Services staff explaining the nature of proposed use and giving the title, name and date of publication, is sufficient.
3. The College and the Trustees reserve the right to require the submission of relevant portions of text before publication. This applies in the case of quotations -
  - a. of 200 words or more
  - b. of entire documents
  - c. from Liddell Hart Centre for Military Archives holdings under 30 years old
  - d. from the papers of FM Sir William Robertson (this includes citations)
4. Please note that the above stipulations include PhD theses, since these are made available for public consultation after acceptance for a degree. Additionally, all readers who have been given access to closed records will, as a matter of course, be required to submit relevant extracts of their texts prior to publication.
5. Texts should be forwarded to Archives Services staff in the first place who will refer them as may be appropriate, to the College Officers, the Trustees of the Liddell Hart Centre for Military Archives, or owners of collections.
6. General acknowledgements for permission to use papers in the College Archives should be made to King's College London. Permission to use the Liddell Hart Centre for Military Archives holdings should be acknowledged to The Trustees of the Liddell Hart Centre for Military Archives.
7. No copyright material should be used in any publication without first obtaining permission from the copyright holder.
8. Readers seeking to publish images and copies of archive documents should contact Archive Services staff for advice. A reproduction fee will be payable unless the publication is not-for-profit.
