Application instructions

The application to our PhD programme has three parts, all of which are mandatory and must be completed prior to the application deadline.

In **Part A**, you will select your 3 preferred projects and contact the supervisory teams to express your interest.

In **Part B**, you will provide information about your education, employment, research experience, academic achievement, as well as your research interests and reasons for pursuing a PhD. This information is used for anonymised shortlisting. Applicants that progress past this stage will be invited for an interview.

In **Part C**, you will complete a diversity monitoring form to help our programme to monitor equal opportunity during recruitment.

Part A: Select your 3 preferred projects

Part B: Application through the [King's Apply website](#)

This part has two steps. First, you will enter information on this website. Second, you will upload a completed application form. **You must follow the instructions below carefully.**

Part B Step 1: Instructions for King's Apply

- 1. Choose a programme**
 - Programme name: Select **CDT in Multiscale Models for Life**
- 2. Getting Started**
 - Are you applying via a King's Approved Agent, King's Partner or Study Aboard Coordinator? Select **No**
 - Please select a start date from the options below: Select **October 2024**
- 3. Personal Information**

- Complete this section.
4. **Education**
 - Education/Academic Qualifications: enter all the relevant information, using the “Save & Add New” option to provide all the information related to your university level education. Upload all corresponding transcripts.
 - Professional/Other Qualification: Select **No**
 - English Language: Select relevant option.
 5. **Employment History**
 - Enter “**See uploaded application form**”
 6. **Supporting Statement**
 - Enter “**See uploaded application form**”
 7. **References**
 - Enter the details for 2 referees.
 - Only when you submit your application will the King’s Apply website contact them for letters of reference.
 - **We strongly recommend that you notify your referees as early as possible** so that they can send in their references before the deadline.

 8. **Funding**
 - Select **Option 5: “I am applying for a funding award or scholarship administrated by King’s College London.”**
 - Award Scheme Code or Name: Enter **MM4L CDT**
 9. **Check and Submit**
 - Submit your application once you have entered the above.
 - You should see a confirmation message and receive a confirmation email.
 - Now continue on with the Application Form.

Part B Step 2: Instructions for the Application Form

1. **Complete the application form**
 - Download the application form [here](#)
 - Follow the instructions in the form and complete all the sections.
2. **Note down your King’s Portal application number**
 - Go to the Current Applications tab of King’s Apply.
 - Click on **CDT in Multiscale Models for Life**

- Your 6- or 7-digit portal number will be on the top right of your Application Overview.
3. **Save your completed application form in PDF format with the portal number as the filename**
 - For example, if your portal number is 7654321, then save your application form as 7654321.pdf.
 - **Please ensure that you use the Portal Number (NOT the King's Student Number).**
 4. **Upload this PDF file into your application on King's Apply**
 - Under the Current Applications tab, click on **CDT in Multiscale Models for Life**
 - Scroll down to **Funding**.
 - Update the funding information on your application form: select **Yes**
 - Scroll down to **Option 6. Other**
 - For Organisation Name and Organisation Type: enter **King's College London**
 - For Document Category: select **Other**
 - Upload your PDF file and click on Save.

Part C: Diversity Monitoring Form
