It engages in original, legal and multi-disciplinary scholarship in the broader field of European law and provides a forum for debate on matters of law and policy engaging with the wider community. It organises international conferences and regularly welcomes visitors from academia, government and international institutions. The successful candidates will be expected to take an active part in the scholarly activities of the Centre. The Dickson Poon School of Law was ranked first for research quality in the 2014 Research Excellence Framework exercise which is the official system for assessing the quality of research in UK higher education institutions.

Eligibility criteria

- Open to residents of the following countries: All Nationalities (Home, EU and overseas candidates).
- Due to commence a full-time research degree programme in European Law during 2023/24 within The Dickson Poon School of Law. Please note that:
 - i) Existing research degree students are not eligible to apply;
 - ii) These scholarships cannot be held on a part time basis.

Application procedure

Applicants must complete and submit an application for <u>Law Research MPhil/PhD</u> by 1 **December 2022** via King's Apply portal through the provided link. This deadline is absolute. Materials received after this specified time and date will not be accepted and the applicant will be considered ineligible.

Please carefully read the Law MPhil/PhD application page for the documents you must submit with your application.

The research proposal you submit with your application must include enough information to enable the selection panel to assess your suitability for this award. You should address the following:

- 1) The theoretical background to the proposed research and its relationship to previous work in the relevant field;
- 2) The significance of the proposed research;
- 3) Explicit reference to the transnational outlook of the proposed research;
- 4) The likely methodological approach and why it is appropriate to the aims of the project;
- 5) How your proposed research complements your previous experience and anticipates possible future research work;
- 6) Why you feel your project fits with your proposed supervisor's research and the strengths of The Dickson Poon School of Law.

Research proposals must NOT exceed 2 sides of A4 (Times New Roman Font size 11) in total. Longer proposals or those that contain extraneous material will not be considered.
