# <u>Managing and Leading Your Team in a Period of Hybrid Working: A Webinar</u> Course for Managers in Adults' and Children's Services

The last 2½ years have seen working practice in social work change significantly. At the height of the pandemic, most of the workforce was working largely remotely. This placed particular demands on managers attempting to lead teams, ensure high quality services for those who use them alongside the wellbeing of staff. It is clear that we will not be "going back to normal". While staff are carrying out more face-to-face meetings, and visiting their offices less, we are seeing new models of hybrid working emerge. This webinar will explore the implications for management and supervision. It will look at the growing body of research on remote working and think about its implications for social work across the different aspect of supervision. Each session is a standalone seminar but, together, they constitute a course that will seek to cover many aspects of learning and managing teams.

### Critical Thinking and Analysis in Social Care

Date: 16/11/22 ,11am -12.30pm

In social work with adults the importance of the capacity for practitioners to exercise critical analysis and reflection is widely recognised. It impacts on abilities to manage

complex casework and therefore improve the quality of their assessments and decision making. If this is true generally in our field of practice, it is particularly so in

this current period. Department of Health and Social Care (DHSC) guidance recognises that social workers are working in circumstances where established practice and processes have to be adapted, especially when face to face contact with service users is limited. This webinar draws on the theoretical and research-based knowledge and tools associated with critical reflection and attempts to apply these ideas to the current context of practice.

Practitioners will be able to reflect on:

- The ongoing implications of the pandemic for social work practice and the delivery of care and support to adults and their carers;
- Recognise the role that reflective and critical thinking plays in producing high quality assessments and purposeful support and safeguarding plans;
- Understand the systemic processes that promote or impede reflection in practice;
- Explore a range of conceptual models that underpin reflective practice;
- Discuss the relationship between critical reflection, emotional intelligence and relationship building;
- Consider the links between reflective analytical thinking and anti-oppressive practice;
- Share helpful research-based resources for practice.

## What Do We Mean By Poverty Aware Social Work?

The UK is currently experiencing a severe economic and potentially social crisis. The cost of living crisis is putting a severe strain on individual families and communities. It comes in the wake of the pandemic and a decade of austerity that has seen growing poverty inequality and hardship. Social justice has been an important dimension to the social work profession's development. The current crisis has brough discussions about how social workers respond to poverty at a child and family as well as community level. As such there has been growing interest in the idea and practice of poverty aware social work. This seminar will explore the literature and research in this area and consider its relevance to contemporary practice.

## Loneliness and Social Care

2023: Date TBC

One million people aged 65 and over in the UK report they are often or always lonely, and this has been exacerbated by the pandemic. However, loneliness and social isolation are conditions that are difficult to identify, complex to address and hard to resolve. Indeed, loneliness and isolation are an issue that affects not only older people but many others who are using social care services. It is also an issue that raises wider public health concerns. The evidence base for interventions to address the problems of loneliness and social isolation is emerging and, while inconclusive at this stage, can offer some important insights in how we can address them.

This webinar will look at the implications for those working in adult social care, and focus on:

- The impact of loneliness and social isolation on health and wellbeing across the life course;
- What works to help address loneliness and social isolation;
- The challenges faced by practitioners and those delivering interventions;
- How these challenges might be overcome.
