

## The Continue at King's Alumni Bursary Scheme 2022

### Terms and Conditions

#### 1. INTRODUCTION

- 1.1 The Continue at King's Alumni Bursary Scheme (the "**Bursary**") offers a £5,000 discount from the total tuition fees payable for King's postgraduate taught courses for recent King's graduates who satisfy the criteria set out below. For eligible graduates, the discount will be automatically applied to their tuition fees and graduates will not be required to submit a separate application.

#### 2. THE BURSARY

- 2.1 The Bursary can only be applied to graduates meeting the criteria set out in these Terms and Conditions, and in particular those conditions listed in paragraph 3 below. Eligible graduates can receive the Bursary only once.
- 2.2 The Bursary is available to full-time postgraduate taught courses only ("**Courses**"). It is not available for PGCE courses, research degrees, or for online courses run by third parties (e.g. Pearson).
- 2.3 The Bursary can only be applied to Courses starting in the year of application and cannot be applied retrospectively. If an applicant defers their offer of a place on a Course to the following year, a fresh application for the Bursary will need to be made.
- 2.4 The Bursary will be applied to a graduate's tuition fee account in respect of their Course and will not be available in any other form. For example, the Bursary cannot be used against accommodation fees or other services provided by King's, and no cash alternative will be provided.
- 2.5 The Bursary is subject to continuing and satisfactory attendance on the student's Course and compliance with King's academic regulations, and will be terminated if the student withdraws from their Course, transfers to another institution, fails their Course, or interrupts or suspends their studies.
- 2.6 The Bursary will be applied to a graduate's tuition fee account in respect of their Course and the balance shall be invoiced to the student and be payable in accordance with the General Terms and Conditions for Students
- 2.7 In instances where a student withdraws from King's part way through their Course having only paid a portion of their tuition fee, the student will not be required to reimburse King's the value of any discount received to date, and the discount shall continue to be applied for any future tuition fee payments the student is liable for (further details of which are set out on the King's [website](#)).

#### 3. ELIGIBILITY

- 3.1 The Bursary is only available to graduates who:
- 3.1.1 have been or will be awarded an undergraduate degree from King's in 2022;
  - 3.1.2 have not already received a postgraduate degree from King's or any other institution;
  - 3.1.3 have "home" fee status when they enrol on their Course; and
  - 3.1.4 were recipients of the [King's Living Bursary](#) or the [Care Leaver and Estranged Bursary](#) during the final academic year of their undergraduate degree, or in the case of medical / dental students, in their final non-NHS funded year.
- 3.2 The Bursary is not available to graduates who are receiving any other grant, scholarship, sponsorship, or any other external funding.

#### 4. APPLICATION AND AVAILABILITY

- 4.1 Every eligible graduate who applies for their Course by the closing date of 25 March 2022 ("**Closing Date**") shall be automatically considered for the Bursary.
- 4.2 Successful applicants will have the Bursary automatically applied to their tuition fee account when they enrol on their respective Course.
- 4.3 Eligible graduates who apply for a Course after the Closing Date may be offered the Bursary, but at the discretion of King's. No guarantee is made to any graduate applying for the Bursary after the Closing Date.

## **5. PUBLICITY**

Whilst studying their Course (and for a period of 3 years after graduating from their Course), recipients of the Bursary may be asked by King's to complete one or more surveys that evaluate the effect of the Bursary and may also be requested to co-operate with publicity activities e.g. providing quotations or blog / social media content.

## **6. INTERPRETATION**

- 6.1 The award of the Bursary is made entirely at the discretion of King's and the judgement of King's is final.
- 6.2 King's reserves the right to vary or withdraw the Continue at King's Alumni Bursary Scheme at its sole discretion but changes will not be applied retrospectively to any graduate who is already in receipt of a Bursary under the Continue at King's Alumni Bursary Scheme unless they withdraw from their Course as set out in paragraph 2.7.
