



## In 2022, King's India Institute celebrates its 10th anniversary

We do so at a time in which India is at the forefront of the world's most pressing transformations – whether that's arriving at a global net-zero future while adapting to the reality of climate change, contributing to global health innovation in the wake of the COVID-19 pandemic, or the promises and associated risks of the digital revolution for the economy, politics and society.

India is the world's fifth largest economy and will soon be the world's most populous country – home to more than one in six people in the world. The Indo-Pacific region is also one of the most strategically significant theatres for global geo-politics.

Meanwhile, at home, the entrenchment of majoritarian politics has raised concerns about the resilience of democratic institutions, while young Indians are at the forefront of new forms of activism and protest.

For these reasons and more, the need for a hub of research and teaching excellence to deepen public understanding of contemporary India remains pressing.

More than 200 students have graduated from the Institute's master's and PhD programmes since our launch under our founding director Professor Sunil Khilnani.

We have also led a range of executive education programmes, including the UK Foreign, Commonwealth and Development Office's South Asia Diplomatic Academy, as well as the Chevening Financial Services Leadership and Chevening Gurukul Leadership Programmes.



Our teaching is complemented by a rigorous research culture. We have attracted over £2.6 million in research grants and fellowships, from funders including the British Academy, Economic and Social Research Council, European Commission, Leverhulme Trust, Science Museum and the UK-India Education Research Initiative.

Now, as we look to the future, we continue to nourish our many valuable partnerships and are honoured to host the Avantha Chair – a prestigious position responsible for advancing the mission of the King's India Institute – as well as the Jawaharlal Nehru Memorial Lecture series and the Inlaks-King's India Institute visiting PhD fellowship.

### **OUR LATEST RESEARCH**

### **Reimagining India's health system**

Despite the heavy toll of COVID-19 and a history of under-investment in public health, Indian voters still don't typically highlight health as a factor bearing on their voting decisions. Similarly, most politicians don't foreground health in their electoral campaigns or priorities in office. Professor Louise Tillin and partners are investigating why exactly this is. The findings from

their five-state survey will give a better indication as to whether there is latent public demand for greater government prioritisation of this sector. The project is funded by a British Academy grant, in partnership with Lokniti (Centre for Study of Developing Societies), the Lancet Citizen's Commission on Reimagining India's Health System and Royal Holloway, University of London.



## Exploring the future of UK-India trade

Led by Dr Sunil Mitra Kumar and Dr Kamini Gupta (King's Business School), this project studies the key enablers and obstacles of UK-India trade: first by building a macro-picture of trade between the two countries, particularly the ongoing negotiations towards a free trade agreement. Then by analysing the role of small, skill-intensive firms in India's exports to the UK and the interlinked role of access to credit and social networks in supporting their growth. The three-year project is funded by the UK Economic and Social Research Council and the Indian Council of Social Science Research. It is a collaboration with the Indian Institute of Management Bangalore and the Federation of Indian Chambers of Commerce and Industry.

## Understanding India's politics in its own terms



The logic of Indian citizens' political choices, decisions and judgments does not lend itself readily to Euro-American analytical concepts: rights, identity, secularism and so on. 'India's Politics in its Vernaculars' is a European Research Council-funded project led by Anastasia Piliavsky that seeks to understand India's politics through Indian citizen's own terms. Twenty-four scholars are working in seventeen Indian languages (including English and Hinglish) to describe key vernacular words and analyse key concepts across India's political terrain. Together, we hope to prompt a shift away from exogenous, perpetually imperial theorising towards a truly Indian theory of India's political life.

### **Artefacts of Resistance**


'Artefacts of Resistance: creating archives of transnational protest movements', by Dr Srilata Sircar and Manu Luksch from Somerset House Studios, is a digital media archive documenting contemporary protest movements that build on transnational solidarity networks. While building an accessible, dynamic portal for protestors, researchers, artists and students, the project's innovative audio-visual performance demonstrates the project's capacity to communicate, inspire and unite. It was funded by the King's x Somerset House Studios research and development scheme.




# Populism in Indian and US foreign policy

Undertaking a comparative study on the role of populism in different contexts, this project examined how foreign policy and international relations can be used for populist mobilisation, and how populism impacts international order. Led by Thorsten Wojczewski during a Leverhulme Early Career Fellowship at the India Institute (2018-21), it found that populism can shape the style of foreign policymaking and result in personalisation, simplification and emotionalism due to attempts to appeal directly to people – but that it does not necessarily influence its content.


