**Intrapartum PERs** p.55 example changed, copy reads: Calm, no cry, pale at birth but became perfused quickly

**Postnatal PERs** p.87 delete any reference to the EC directive in top box

**Neonatal PERs** p.122-143 delete any reference to the EC directive in top box, age needs to be in hours not days, 'pink' changed to 'perfused'

p.144 second column needs to state age in hours rather than days

**Summary of progress** p.195 delete any reference to the EC requirements in 2<sup>nd</sup> row, 2<sup>nd</sup> column – change wording

p.195, p.212 and p.229 intrapartum care needs to be reformatted to include rows for 'women supported and cared for in labour (birth personally conducted)' and 'women supported and cared for in labour (vaginal birth not personally conducted)' and 'Cared for in labour' with the same columns 'Universal care' and 'Additional care', additional care blocked out for 'Births personally conducted'

p.229 intrapartum care needs to be reformatted to include rows for 'women cared for in labour and supported during birth' and 'women cared for in labour and birth personally conducted' and 'Cared for in labour' with the same columns 'Universal care' and 'Additional care', additional care blocked out for 'Births personally conducted'.

p.229 Systematic exam numbers added to Neonatal numbers

**Reasonable adjustments** p.240 insert new text and NMC standards link
