About the course

The European Union Law Summer Short Course is hosted by the Centre of European Law. The course is highly regarded for teaching excellence and research expertise. Delivered in person across eight days of full-time study, the course offers an intensive programme of lectures and interactive workshops led by experts in academia and practice. Participants will gain an advanced understanding of the central concepts, methods and debates in current EU Law, and focused study in areas such as trade relations and international conflict. Particular attention will be given to international conflict in Ukraine and separation from the EU, with Brexit as case study. Participants will develop the skills required to solve EU legal problems; understand the legal implications of EU actions in areas of defence or trade relations with the UK; be able to search for and interpret data on EU Law as required across legal practice.

The short course programme may be subject to minor changes.
