

Parent/Legal Guardian Agreement to Study Form Pre-University Summer School

Student participation in any King's College London Pre-University Programme requires consent from the parent or guardian.

King's College London has a particular duty to protect children under 18 who apply or are admitted to the university. Under English Law, a "child" is legally a person under the age of 18.

As the parent or legal guardian of a student who will be participating in a programme designed for high school students and therefore with a large proportion of students under the age of 18 at the time of enrolment, you are required to read the Parent/Guardian Information Document and complete this agreement form. This is a requirement for all students, regardless of age.

It is important that this form is completed by you, the parent or legal guardian, but if necessary please talk through the form with the student as you complete it.

This form should be submitted by the student upon acceptance of their offer or by 31st May 2019 at the latest. Please note that a delay in returning this form can affect the student's eligibility to enrol onto the programme.
